

## **Important Compliance Message**

As you know, San Luis Obispo Caregivers is a referral agency created to provide job opportunities for local independent caregivers. We help you find jobs, so you can simply care for your client.

The Problem! In 2020, California introduced new requirements for Independent contractors, which can be confusing to understand but are important for you and San Luis Obispo Caregivers, A Referral Agency. Independent Caregivers are by definition a business and we need to be able to prove that you are complaint with the new regulations.

The Solution! To show you are an independent contractor...you need to prove you are a business. Here are two options.

- 1. The clearest way to show that you are a business is to get your own business license. This typically costs around \$200. Create a company name for your business and register with your city or county.
- 2. Some caregivers have chosen to sign up for an Employer Identification Number (EIN) with the IRS. This is a free process that takes a few minutes online; <a href="https://sa.www4.irs.gov/modiein/individual/index.jsp">https://sa.www4.irs.gov/modiein/individual/index.jsp</a>

Once you complete either step 1 or step 2, just provide us with a copy of the license or the EIN. Also, we have updated the Caregiver Agreement with the new 2020 requirements to make sure we remain in compliance as well. We will be sending the new agreements on Adobe Sign so you can sign it online. I appreciate your partnership with my company and I look forward to your continued success.

### What type of legal structure is applying for an EIN?

Before applying for an EIN you should have already determined what type of legal structure, business, or type of organization is being established.

Choose the type you are applying for. If you don't see your type, select "View Additional Types."

## Sole Proprietor

Includes individuals who are in business for themselves and household employers.

## Partnerships

Includes partnerships and joint ventures.

## Corporations

Includes S corporations, personal service corporations, real estate investment trusts (REIT), regulated investment conduits (RIC), and settlement funds.

## Limited Liability Company (LLC)

A limited liability company (LLC) is a structure allowed I state statute and is formed by filing articles of organization with the state.

### Estate

An estate is a legal entity created as a result of a person's death.

### □ Trusts


All types of trusts including conservatorships, custodianships, guardianships, irrevocable trusts, revocable trusts, and receiverships.

#### What it is...

- A sole proprietorship is a business owned by one individual.
- A sole proprietor can be a self-employed individual or an independent contractor.
- All business income and expenses are reported on the individual's federal income tax return.
- · A sole proprietor may or may not have employees.

IMPORTANT: A sole proprietor may have only one EIN, regardless of the number of businesses you own or operate. If you already have an EIN, you must use that number for all of your sole proprietor businesses.


### What it is not...

 The business cannot be <u>incorporated</u> or registered with the state as a <u>limited liability company (LLC)</u>.

If you need to change your type of structure, we recommend that you do so **now**, otherwise you will have to start over and re-enter your information. Additional help may be found by reviewing <u>all types of organizations and structures</u> before making your selection.
